## From the Presidents Corner

As I see it, I get WAY TOO MANY E-MAILS! Whoa! don't be offended. I'm not getting them from OMUG members, so in that respect I may be preaching to the choir. Actually this subject was suggested by an OMUG member who must be getting too much email, as I do, from uninformed e-mailers. Maybe, just maybe, you can use some of what I am going to say to respond to or to educate some of the folks who torment you by using e-mail inappropriately. The email I received with my comments added follows:

1) Any time you see an E-Mail that says forward this on to '10' of your friends, sign this petition, or you'll get bad luck, good luck, or whatever, it almost always has an E-Mail tracker program attached that tracks the cookies and E-Mails of those folks you forward to. The host sender is getting a copy each time it gets forwarded and then is able to get lists of 'active' E-Mails to use in SPAM E-Mails, or sell to other spammers. **Research I have done, primarily at snopes.com, indicates that there is no such thing as an e-mail**

**tracker program. However there are such things as "key logger" programs that will surreptitiously send your keystrokes back to a central host. Personally, When I get an email that insists that I send it to others, I do not. Just the rebellion in me I suppose. Spammers do get a lot of email addresses from these types of emails when they are forwarded without using the "BCC" feature to hide most of the recipients. I have seen emails from which I could have harvested over 100 addresses. I even found the email address of a high school sweetheart this way! (Don't tell Shelley).**

2) Almost all E-Mails that ask you to add your name and forward on to others are similar to that mass letter years ago that asked people to send business cards to the little kid in Florida who wanted to break the Guinness Book of Records for the most cards. All it was, and all any of this type of E-Mail is, is a way to get names and 'cookie' tracking information for telemarketers and spammers - - to validate active E-Mail accounts for their own profitable purposes. **True, and most of these that you see have been resurrected from times past. Even if they were true, they are now out of date and the "send to" address is either obsolete or just wants to be left alone.**

You can do your friends and family\_

members a GREAT favor by sending this information to them; you will be providing a service to your friends, and will be rewarded by not getting thousands of spam E-Mails in the future! **TRUE**

If you have been sending out (FORWARDING) the above kinds of E-Mail, now you know why you get so much SPAM! **TRUE**

Do yourself a favor and STOP adding your name(s) to those types of listings regardless how inviting they might sound! **TRUE**

You may think you are supporting a GREAT cause, but you are NOT in the long run. Instead, you will be getting tons of junk mail later! Plus, we are helping the spammers get rich! Let's not make it easy for them! **TRUE**

Also: E-Mail petitions are NOT acceptable to Congress or to any other organization. To be acceptable, petitions must have a signed signature and full address of the person signing the petition. **TRUE to a point.**

This comment refers to those petitions that ask you to add your name and address to the list and forward to X number of people. If an email from a **REPUTABLE ORGANIZATION** asks you to click a link, register your name and address etc. and to sign a petition; these can be legit and effective. By doing it this way, they can verify that you have not signed the petition twice, that there really is such a person, etc. When Congressmen get petitions with thousands of verified names they will listen. The unverified, often duplicated names on the petitions referred to by this writer are ignored.

## **MORE From NCS**

I get e-mails asking me to pray for our troops and to forward to x number of others. I do not need to be told to pray for our troops. I do so every night, not only our military but also all those like police officers and firemen who risk their lives every day to protect others. I assume that other people so inclined, do the same and I do not forward these well meaning e-mails.

I get a lot of funny and/or interesting emails. If they do not insist that I forward them to others I frequently do. I confess, for the best, I will forward even the ones that offend me by telling me to do so. BUT, I do not just hit forward and let er rip. I copy and paste into a new email addressed to me and BCC the intended recipients to protect their privacy. I do not copy and paste the sentence about send this to X others. If the email is in such a format that copy and paste will not work and I have to forward, I forward to me and BCC the others and delete all the info about where it came from. Different e-mail programs work differently but you should be able to find a way to forward mails without sending out other peoples email addresses.

One of my biggest pet peeves is receiving emails damning a person or organization (usually political) with fictitious slanderous information or photoshopped pictures to prove someone did something he/she did not or was somewhere he or she was not.

I do not like to get emails giving me false health or diet information. If I get stuff like this I check it out on Snopes.com and or Google before use it or send it on. If it is false, I tell the sender. If the sender persists in

sending me fictitious information, (and frequently these offenders also use CC instead of BCC) I hit "REPLY ALL" instead of just "reply" when I send corrected information.

## Apple News

### Apple computers getting touchy-feely?

Apple Inc has filed a patent application for a way to apply touchscreen technology to a computer.

In papers filed with the U.S. Patent & Trademark Office on Thursday, the Cupertino, California-based company appears to be looking for a way to take the touchscreen technology showcased on its iPhone and give it new life on computers. (Note - your browser may need a plug-in available through the Patent Office site's help section to see the drawings.)

AppleInsider reported on Apple's patent filing in a story posted on its [Web site](#).

Apple said in its filing that the computer mouse and the touch pad are limited in the kinds of gestures

they allow users to perform, and that its invention for a multipoint sensing device will open up new possibilities.

The patent application details ways for a user to zoom in on an image on the screen and perform functions by touching one or another icon. The iPhone already uses finger gestures for navigation, a handy piece of technology because the device is too small for a keyboard.

Apple's application also describes how users could touch a screen with gestures and make use of a simulated keyboard on the screen.

Of course, it remains to be seen if, having made this patent application, Apple develops it further.

Members were reminded about our new business cards for distribution Richard Rohde inquired about last month's "no show" presenter from the Star Banner and apparently the newspaper said that they are switching from PC's to MAC's and OMUG got lost is the shuffle! N. C. reminded the membership about getting those Surveys and Bio's in. He brings his camera with him to the meetings should anyone need a photo for his or her Bio.

This month's speaker was Rudi Gasser, five year member of OMUG who splits his time between Switzerland and Rainbow Estates here in Ocala (Rudi speaks English (of course), French, Italian, German and Switzedeusch). For his iMovie/iDVD presentation, Rudi listed his equipment as follows: iBook G4, processor 1.33 GHz, OS 10.4.11 Tiger, Sony Handyman PC8E, PAL camera, fire wire, iLife '06(iMovie, iDVD, iPhoto and iTunes. First he connects the Fire Wire cable to his Video Cam and then connects the cable to the computer and opens iMovie, selects "Create New Project" and names it. With his video Camera, he took us through an evening cruise out of New Orleans on the Riverboat

"Natchez", sharing his camera techniques; hand held (no tripod), zooming (minimal recommended), panning, selecting out stills from clips, transitions between clips and chapters, adding text and titles and the editing sound (iTunes) is last. Throughout his presentation, he reminds us to "Save Often" (this is the credo of all computer use). Of particular interest to Rudi was the steam driven boat itself ~ a 1925 steam engine transplanted into a '70's steel hull, everything up to code, as per the U.S. Coast Guard regulations. Time was running out and as there was so much information, Rudi has agreed to continue his presentation for our November meeting. All of the stages of creating an iMovie were very well articulated and demonstrated and I feel that we got a pretty clear picture of how to share our still photography and video with friends and family.

Tip Time..... Phil Davis said to go to the right side of the web page to "send a tip" and that there are always great Mac tips there on all subjects. Sally Smyth commented to Phil on a glowing compliment that she had gotten on OMUG'S website and he told us all that Merrill Anderson had been a great help with her artistic suggestions. Here is a copy of an email that I received from Phil....."Sally, I want to add to what I said about Merrill regarding the web site. She has been an invaluable partner in the development of the new site. I'm pretty good at building sites and I can usually spot when something is not quite right in the layout and color scheme. But I'm no artist and usually don't have a clue as to why it is bad or what to do about it. Merrill has taken the time to critically examine my efforts and then, not only tell me what is wrong artistically, but what to do to fix it. Not only is she kind and talented, but

she is a very good teacher. I feel very lucky to have her advice and assistance on the site and look forward to continuing to learn from her. Cheers Phil". Doesn't that just say it all and thank you Merrill from our entire membership.

After refreshments were served (thank you, as always, Carolyn and Bob), 50/50 winners were: Jack Wood, \$31 (Angie Wood drew the next winning ticket and she turned it back in), Selwyn Julian's ticket won him that \$31; Louis Wahl and N.C. Sizemore took gifts from the goody table.

## Tip Of The Month

### Mac OSX Tip: Text Field Auto Completion

If you're typing in a text field (in Safari, TextEdit, or most any Mac OS X app), you can press F5 while your cursor rests in a particular word to see a list of words that begin with the letters after the last space.

Pressing Escape works, too.

So, for example, if you type create, you get a list of words including create, created, and creates.

If there are a lot of words in the list, it only shows the first 100 results, sorted alphabetically. The results come from Mac OS X's built-in dictionary.

This trick is useful for when you have a word on the tip of your tongue, need help with possessive apostrophes, or are stuck on a crossword clue.

**Editors Note: Don't try this with Appleworks. It does not work. I tried it out also on Mail and all is well. That alone was worth the price of admission.**
